#### WHO IS ELIGIBLE?

To be eligible for the Certificate 3 Guarantee Program, a participant must:

- · be aged 15 years or older;
- be no longer at school (with the exception of school students in Years 10, 11 and 12 undertaking a VET in School (VETiS) program);
- · permanently reside in Queensland;
- be an Australian citizen, Australian permanent resident (includes humanitarian entrant), temporary resident with the necessary visa and work permits on the pathway to permanent residency, or a New Zealand citizen; and
- not hold, and not be enrolled in, a certificate III or higher-level qualification, not including qualifications completed at school and foundation skills training.

# A participant can be unemployed and seeking work, or working on a full-time, part-time or casual basis.

Acceptance is subject to eligibility criteria and availability. In addition to the standard eligibility requirements, specific restrictions and/or exemptions may apply to participation in certain subsidised qualifications. Please contact our sales team if you have any questions.

#### STUDENT CO-CONTRIBUTION FEE

A Student Co-Contribution Fee applies to all students partaking in the Certificate 3 Guarantee Program. This fee is charged and collected in full prior to enrolment.

Concessional Participants are defined as follows:

- (a) the participant holds a Health Care concession card or Pensioner concession card issued under Commonwealth law, or is the partner or a dependant of a person who holds a Health Care concession card or Pensioner concession card, and is named on the card; or
- (b) the participant can provide an official form under Commonwealth law confirming that the Participant, his or her partner or the person of whom the Participant is a dependant, is entitled to concessions under a Health Care or Pensioner concession card; or
- (c) the participant is an Aboriginal and Torres Strait Islander.
- (d) the participant is a school student and is enrolled in a VETis program (including those in detention); or
- (e) the participant has a disability; or
- (f) the participant is an adult prisoner
